Amal Abou Rafeh is the Chief of the Programme on Ageing Section at the United Nations Department of Economic and Social Affairs in New York. She serves on the Secretariat of the General Assembly's Working Group for the purpose of strengthening the protection of the human rights of older persons. Amal is a member of the Steering Committee of the Titchfield City Group on Ageing-related Statistics and Age-disaggregated Data. She is also a member of the World Economic Forum's Global Future Council on Healthy Ageing and Longevity 2020-2021. Amal joined the United Nations in 2001, working in the areas of social policy, sustainable development and demography, and served on the Secretariats of the World Summit on Sustainable Development (2002) and the High-level Meeting on Youth (2011). She held positions in Beirut and New York. Before joining the United Nations, Amal lectured on analysis of social and demographic data. Amal was born in Riyadh, Kingdom of Saudi Arabia and holds a Master of Science in Population Studies from the American University of Beirut.



Renata Bagatin had a career of 40 years with the Italian Union CGIL as Regional Chair (Segretaria Regionale), then as National Chair of Trade, Tourism and Service Workers. From 1999 to 2013 she was Regional Chair, then National Chair of the Pensioners Union (SPI CGIL). She also represented Italy in the Board of the European Federation of Pensioners (Fédération européenne des retraités et des personnes âgées – FERPA). In 2013 she was elected Regional Councillor of the Italian Region Friuli Venezia Giulia. For five years, she was Vice President of the Commission of Health, Social Services and Nutrition of the Regional Government. Among various other legislative proposals, she promoted the Regional Act 22/2014 on Active Ageing. To date, she continues to be an active pensioner.



Francesco Barbabella is a Sociologist working as Research Fellow at the Centre for Socio-Economic Research on Ageing (CRESI) at INRCA IRCCS, Ancona (Italy). He is also Researcher at the Department of Health and Caring Sciences at the Linnaeus University, Kalmar (Sweden). He has a long track of scientific publications, contributions to high-level policy briefs (published by WHO Europe and European Commission) and coordination of international research projects. His research interests focus on ageing, informal care, long-term care, digital health, and social policy issues.



Dr. Cristina Calvi, is a Sociologist of medicine with a second level master in Epidemiology. Currently she is working as Research Fellow at the Centre for Socio-Economic Research on Ageing (CRESI) at INRCA IRCCS, Ancona (Italy) and she is also collaborating with the Department of Law and Political, Economic and Social Sciences of the University of Eastern Piedmont (Italy) where she is involved in research projects in the field of health. Her main research interests focus on the medicalization of life, ageing, informal care, long-term care and coping strategies of patients and caregivers facing long-term illness. An award winning executive and innovative leader, Margaret played a key role in establishing the Age-friendly Community program in Canada and internationally. Other career highlights include a joint government-NGO project to protect seniors in disasters which was recognized by Her Majesty the Queen. Margaret has strong credentials in regard to human rights, working with and speaking at the UN General Assembly on behalf of older people and as Canadian Delegate to the Organization of American States, Institute for Children. She is currently the Chair of the National Advocacy Working Group at the Global Alliance on the Rights of Older Persons and has been actively working for a United Nations Convention on the Rights of Older Persons in Canada and internationally. With a background in health promotion, protection and programming, Margret is committed to improving the rights of older people.



Dr. Tiago Hashiguchi is a Health Policy Analyst at the Directorate for Employment, Labour and Social Affairs of the Organisation for Economic Co-operation and Development in Paris, France. His work at the OECD seeks to inform evidence-based policies to improve across various health-related areas, including financial social protection for long-term care in old age. Before joining the OECD, Tiago held research positions in London at Imperial Business Analytics with KPMG, and in Seattle at the Institute for Health Metrics and Evaluation. Tiago has a PhD in Health Management from Imperial College London and an MSc in Biomedical Engineering from the Technical University of Lisbon.



A cognitive neuroscientist by training, **Dr. Vijeth Iyengar** is Director of Global Aging at AARP where he leads cutting-edge research, drives thought leadership on global aging issues, and cultivates relationships and strategic alliances to promote AARP's vision in service of older adults everywhere. Prior to joining AARP, from 2016-2021, Dr. Iyengar served in a number of roles in the U.S. Federal Government including as Brain Health Lead and Technical Advisor to the Deputy Assistant Secretary for Aging, as a Policy Advisor to the 4th U.S. Chief Technology Officer at the White House Office of Science and Technology Policy, and as lead author of the 2018-2022 U.S. country report for the Fourth Review and Appraisal of the Madrid International Plan of Action on Ageing. Dr. Iyengar has co-authored articles appearing in leading venues including the Bulletin of the World Health Organization, JAMA Health Forum, Pan American Journal of Public Health, Scientific American, STAT News, and the U.S. National Academy of Medicine. A native of Louisiana, he was a visiting undergraduate student at Cornell University, received his bachelor's degree from Tulane University, and received his masters and doctoral degrees from Duke University.



Giovanni Lamura leads the *Centre for Socio-Economic Research on Ageing* at IRCCS INRCA (Italy's National Institute of Health and Science on Ageing). He graduated in economics, achieved a PhD in *Life course and social policy* (University of Bremen, Germany), and was visiting fellow at University of Hamburg-Eppendorf (Germany) and the European Centre for Social Welfare Policy & Research (Austria). His interests focus on international research on family and long-term care; migrant care work; interdisciplinary research on ageing. He has led several European projects on long-term care issues, including the use of new technologies to support care delivery and reduce the burden of family carers.



Kai Leichsenring has been Executive Director of European Centre for Social Welfare Policy and Research in Vienna (Austria) since 2016. He holds a doctoral degree in Political Sciences from the University of Vienna. Over the past 30 years he has worked in designing, organising, and directing national and cross-national research and development projects in the field of social welfare and health research as well as in consultancy for national and international policy makers. He published a range of reports, articles and books, in particular on long-term care in Europe, integrating health and social care services for older persons, the use of small housing units for persons suffering from dementia, etc.



Edmundo Martinho chairs the UNECE Working Group on Ageing. He has been the provider of Santa Casa da Misericórdia de Lisboa since November 2017, after having been deputy provider between March 2016 and November 2017.

He has a degree in Social Work from the Instituto Superior de Serviço Social de Lisboa, a postgraduate degree in Project Management and Doctor Honoris Causa by the Lusófona University of Humanity and Technologies.

He was the president of the Board of Directors of the Institute for Social Development of Portugal between 1999 and 2003, president of the Institute of Social Security of Portugal from 2005 to 2011 and president of the National Council of Social Security. He was the vice-president and the representative of Portugal at the Social Protection Committee of the European Union and coordinated the National Action Plan for Inclusion (PNAI) between March 2001 and February 2003.



Dr. Heidrun Mollenkopf (*AGE Platform Europe, Civil Society representative to UNECE*) has been Vice-President of AGE Platform Europe until 2021 and Board Member of the German National Association of Senior Citizens' Organisations (BAGSO) since 2014. Between 2007 and 2014, Dr. Mollenkopf was member of the Expert Council of BAGSO and Chair of the “Universal Access and Independent Living” Expert Group of AGE Platform Europe.

Dr. Mollenkopf has a background in sociology and gerontology. She was Senior Researcher at the German Centre for Research on Ageing at the University of Heidelberg until she retired in December 2004. Her main research focus is the interplay among personal, societal, technical, and environmental conditions regarding maintaining autonomy and social participation and, by this, quality of life in old age. She has pursued this interest in several large-scale research projects on technology and ageing and on the outdoor mobility of older persons first at the University of Mannheim, then at the Social Science Research Center Berlin (WZB) and the Free University of Berlin, and finally at the German Centre for Research on Ageing.

She has published widely in the fields of ageing and technology, mobility, senior friendly neighbourhoods and quality of life of older people. In addition, Heidrun Mollenkopf worked as a lecturer at several universities in Germany and Switzerland.



Sergio Murillo Corzo is Minister for Social Action of the Government of Biscay. Previously, he has been for 6 years the Director-General for Personal Autonomy Promotion, in the Department for Social Action.

As Minister for Social Action of the Government of Biscay, he is responsible for the design, implementation and management of public policies addressed to children, older people and people with disabilities. Currently he is leading the Long Term Care transition plan in Biscay, as key issue for the quality and sustainability of present and future public care systems.

He holds a Bachelor in Economics and Business Administration from the University of Deusto (Bilbao), MSc in Management Development. He has a background in management of social and health service centres, education centres and auditing services.



Dario Paoletti, in the past was an IT Project Manager with long experience in business intelligence using IT tools to help companies to discover, identify and share the available data. He has been involved in training for many years and has specialized in adult life long learning. As a volunteer for about 20 years he has been involved in active aging, helping those who lose their jobs at senior age. In 2016 he became a professional counselor and is involved in social inclusion projects for poor families, Roma and immigrants. He has participated in many European projects also as a designer and is a member of two Age Platform Europe task forces concerning the work of senior people and well-being of the elderly. He is also currently organizing a social inclusion project for Ukrainian families. For about two years he is promoting social innovation, ecological responsibility and energy communities in small municipalities.



Andrea Principi is a social gerontologist at the Italian National Institute of Ageing (IRCCS INRCA). She is a part of the expert advisory group of the Minister for Labour and Social Affairs of the Czech Republic since 2022.



Ina Voelcker is the Head of the Secretariat for International Policy on Ageing at BAGSO, the German National Association of Senior Citizens' Organisations. She coordinates BAGSO's international work which involves representing older persons' interests in international policy debates and fostering the exchange of older people's organisations from various countries. Before joining BAGSO, Ina Voelcker was technical director at the International Longevity Centre Brazil based in Rio de Janeiro, where she coordinated the implementation of the Age-Friendly Cities project of the WHO in some Brazilian cities. From 2009 to 2012 she worked at HelpAge International, responsible for producing "Ageing in the Twenty-First Century", a joint report with UNFPA. She is gerontologist and holds a Master's degree in Public Policy and Ageing from King's College London.
