Joint Forum of Civil Society and Scientific Research
for the 4th review and appraisal of the implementation of MIPAA

Rome, 15 June 2022

Background

At the end of the 4th review and appraisal of MIPAA/RIS in the region and ahead of the upcoming Ministerial Conference on Ageing that will be held in Rome on 16 and 17 June 2022, civil society and scientific researchers will be coming together for the first time in a Joint Forum to discuss issues that have been at the forefront in recent years.

Since the completion of this cycle also marks the conclusion of 20 years of MIPAA, the Joint Forum also offers the opportunity to appreciate what has been achieved in the field of ageing over the last two decades. At the same time, it will be discussed in which areas there is still a need for action from the point of view of civil society and science, and what is required regarding future developments. Politicians and practitioners who are confronted with ageing-related issues in their daily practice are invited to participate in the discussions promoted by the Joint Forum and to comment on them.

Rationale and aim

Acknowledging that civil society organisations engage in research and that research institutions engage in advocacy and are also part of civil society, the aims of the Joint Forum can be summarised as follows:

- To break down thinking and acting in separate silos and to enable a joint exchange of experiences and knowledge;
- To jointly discuss issues and findings to underpin the Ministerial Conference with experiences from civil society and evidence from research;
- To foster a dialogue around the most relevant future developments in the field of ageing and related areas from the perspectives of civil society, research and policy making;

- To identify priority areas for future policies on ageing across countries;
- To produce a joint Declaration.

Ultimately, the aim is to improve the living conditions of ageing and older persons by bringing issues of civil society, research and policy making together.

Proposed content:

The Joint Forum will host presentations by representatives of civil society and scientific research, discussions with policy makers on previously agreed topics, and develop recommendations for future policies.

Topics:

These will primarily refer to the following:

- Issues based on the Ministerial Conference's topics:
 - *Promoting active and healthy ageing throughout life*
 - *Ensuring equal access to long-term care and support to families and caregivers*
 - *Mainstreaming ageing to advance a society for all ages*
- Additional items to be collected via civil society organisations and main international scientific organisations (e.g. <https://www.iagg.info>; <https://www.iagg-er.net>) such as, for instance, the specific barriers that older people face in respect of their human rights.

Structure:

One day physical meeting (potentially hybrid with possibility of streaming), organised as follows:

- Introduction / Keynote
- 3 Sessions (according to a general principle of triangulation of civil society, research and policy making)
- Session 4 to discuss a Joint Declaration including policy recommendations for the next 5 years (to be drafted beforehand and elaborated during and after the Joint Forum).

Joint Civil Society and Scientific Research Declaration:

- To be prepared in advance in its core contents (see Session 4)
- To be discussed and finalised at the Forum and presented at the Ministerial Conference.
